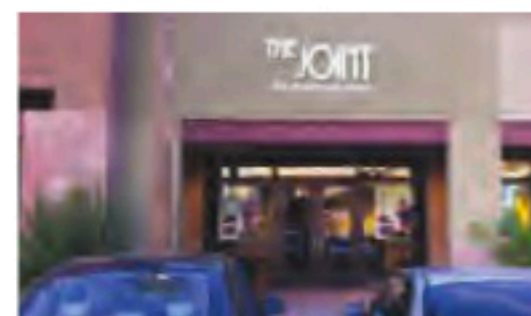
Chiropractic clinic opens
